Registrants who do not cancel or attend forfeit the entire fee. The fee may not be applied to the next scheduled class. An administrative charge of \$150 (Fire) / \$150 (Non-Fire) will be incurred to retake the course and/or test due to failure. Course substitutions are permitted prior to the first day of class.
